Funding scheme: ERA-NET



- to develop and strengthen the coordination of public research programmes (national and regional level)
- ERA-NET: EU funding only for coordination
- ERA-NET Plus: EU top up funding for one single joint call (1/3 of joint call budget – in total > 5 Mio €)

1. Collaboration with / linkage with existing relevant thematic ERA-NET (E RARE, HIVERA, NEURON, INFECT-ERA)
2. ERA-NET with Latin America and the Caribbean Countries
3. Establish a new ERA-NET (HORIZON 2020...?)

Activities planned

- a) Promoting mutual opening and coordination of existing programmes + infrastructures + cooperation – funding of „pilot action groups“
- b) Implementation of 2 Joint Calls (end of 2014 + 2015) - topics identified by EU-LAC JIRI WGs and other initiatives, variable geometry
- c) Coordination of a consultation process (funding agencies and research institutions)
- d) Building up a platform for EU and LAC funding agencies

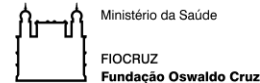
